-The City of Parrottsville and Parrottsville Ruritan Club reserves the right to deny any entry deemed inappropriate at any time.

-Any participant breaking the rules will be removed from the parade lineup.

-A waiver form MUST be signed by ALL participants.

-All participants are encouraged to incorporate the parade's theme into their entry.

-Participants must have an entry suitable for a family audience.

-No Santa Claus replicas may be part of any entry.

-Participants involved in the parade must be drug and alcohol free.

-Smoking is prohibited by any participant.

-The parade route will begin at the staging area at Parrottsville Elementary School and travel along Highway 321 North. To alleviate congestion, smaller autos and entries are encouraged to turn LEFT onto Parrotts Circle just past the fire hall. Tractor trailers, and other large vehicles, are encouraged to turn RIGHT onto Highway 340 SOUTH, then right onto Canary Drive.

-Participants riding on tractor trailers and other large vehicles are encouraged to park and leave personal autos off Canary Drive near the softball field prior to lining up for the parade.

-Horse trailers are encouraged to leave horse trailers parked off Canary Drive near the softball field prior to lining up for the parade.

-All participants must abide by all local, state, and federal laws.

-No reckless behavior (tire squealing, burn outs, etc...) is permitted.

-Candy and other treats are encouraged to be distributed during the parade. But, for safety reasons, must be thrown off the roadway and onto the sidewalk.
